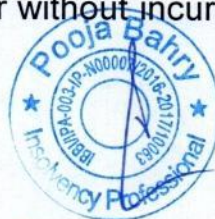



**EXTENSION OF INVITATION OF EXPRESSION OF INTEREST

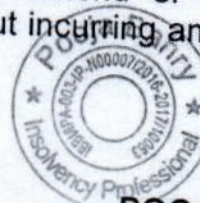
